Anticipated \$40,000 deficit due to increased GVDA expenses and lower than expected membership sales. Chair indicated that although GVDA changes noted below are positive, it presents short-term fiscal challenges. Actual deficit depends on value of investment portfolio at fiscal end. Budget forecast for remainder of 2015 will be ready within two weeks.

9) Economic Development Update

Chair thanks Committee Chair, Dan Dagg, for his work helping with GVDA transition to external regional agency.

Dan Dagg, Committee Chair, reports:

- Met all Mayors in Spring, presented regional model
- Met 12 of 13 mayors plus rep from Southern Gulf Islands in Fall, to present new model, public-private partnership. Unanimously approved, attending mayors to present to their councils.
- Mayors Economic Summit planned for Nov 7
- Start-up anticipated April 1

10) Our Vibrant Community

a. Municipal Monitoring

Committee Chair, John Wilson, reports:

- June and July reports complete
- Funding available for August and Sept.
- Expects pilot project to continue as sponsor funding permits.
- Intend to publish online as a community resource
- Value-added initiative, nil editorial content, all fact-based data.
- All information is from the City of Victoria, in the public domain. Anyone could initiate same project, and should come up with same result.

CEO reports that the promotion of initiative began in July in Business Matters, BizNews, online and via social media. There has not currently been any direct conversation with Mayor as yet.

Chair commends independent contractor on his work, and advised Board that due to Mayor rescheduling desired monthly meetings, there has been no opportunity to discuss.

b. The Chair stated communications with Mayor Helps – and vice versa – is a key aspect of our efforts to build an effective working relationship with the City of Victoria. That being said, The Chamber staff have a job to do, and their advocacy on behalf of the business community should not be constrained by concerns about negatively affecting that relationship.
