10) Budget Post Mortem

The Chamber highlighted two areas in the budget, the Digital Media tax credit extension and the expansion of the Animation & Visual Effects tax credit to include post-production work. Relevant to both the video gaming and film industry locally.

The BC Budget allows for increases to the hotel tax from two to three per cent. Details on this will be made available later in the year.

Regarding tax incentives for Government Street revitalization - The Chamber is happy to discuss but warns that it would be complex to implement.

Dan Dagg reports update. GVDA is working on a succession plan, Dan to be incoming chair of GVDA, Craig Norris vice-chair and additional positions of a Finance Chair and Executive Large.

GVDA met with Nils Jensen and Bob Lapham from the Capital Regional District regarding CRD funding to GVDA. They seemed receptive to the idea.
