# **Capital Region Governance Review Committee**

Committee has been renamed to reflect the agnostic nature of the study process in terms of identifying best options for the region whether that be amalgamation or regional efficiencies or an alternate.

Province has money set aside for the study but requires letters from all municipalities to initiate this study. Chamber will add our voice to this group of letters. Committee's role is to assist in shaping the study to define a clear outcome that can be actioned. Skill sets and regional representation for the committee is key and more members are welcome. Board to email Mark with region that they will help to liaise with on this.

# 6) Economic Development

#### **Committee Chair**

All municipalities are showing increased awareness and focus on economic development either locally or through GVDA. Additional funding by CRD and municipalities is being targeted. WD Project may reallocate some money between projects, this will return to the board for approval once the GVDA committee has reviewed.
