## 2. Chair's Remarks

It has been another busy but positive month with good local engagement, top notch speakers garnering national attention and high attendance. The city of Victoria is introducing an aggressive agenda of being climate neutral by 2030? The Chamber indicated that businesses are committed to that change but need support and cost recovery assistance. PEI has introduced the bag bylaw that Victoria pioneered and The Chamber will continue to advocate that the entire CRD adopts one rule for the entire region. Belleville terminal upgrades are currently accessed as higher than original but working to keep the upgrade going and attain pre-clearance for the upgraded facility. The Chamber discussed accepting as members Cannabis dispensaries with business licenses as we rapidly move towards full legality in October. Discussions include The Chamber's role in supporting small businesses, role of being forward thinking, reputation management, qualification of these businesses and where the federal legislation is in the approval process.
